Note for Applicants – General M.S.S.A. Endorsement

This form is to be used to apply for an endorsement in respect of military style semi-automatic firearms pursuant to s30B of the Arms Act 1983.

This endorsement must be made specific to a particular MSSA firearm before you can take possession of that MSSA firearm. If you intend to obtain a MSSA firearm from a third party, either in New Zealand or overseas, the endorsement will be made specific once you obtain a permit to procure or a permit to import. If you intend to create a MSSA firearm for example by manufacture, assembly or by converting a sporting firearm, you will need to apply on form POL 67X, once this general endorsement has been granted (or in conjunction with this application).

You may not take possession of any firearm in MSSA configuration unless a specific endorsement for that firearm is made as above, and you comply with regulation 28 of the Arms Regulations 1992. Regulation 28 requires you to seek Police approval for your secure storage arrangements. Guidance is contained in POL67N. You may request inspection and certification of your MSSA secure storage at your premises in conjunction with this application. If storage is not inspected at this time, the Commissioner of Police will impose a condition upon this endorsement requiring you to install secure storage and have it approved by Police before the endorsement is made specific to a particular MSSA firearm. This may make your application for a specific endorsement (whether by permit to procure, permit to import of POL67X) take longer.

Prerequisites:

- 1. You must have, or be an applicant for, a New Zealand firearms licence
- 2. You must be of or over 18 years of age.

Reasons for Possession of a MSSA firearm:

In considering your fitness to possess MSSA firearms, Police will ask for your reason(s).You may advance any reason and it will be considered by the member of the Police.Common reasons are:

The individual applying for the endorsement:

- 1. seeks to possess the MSSA as part of a collection, and demonstrates that it fits with and enhances an existing or planned collection, or
- 2. participates in an identifiable shooting discipline or sport at an incorporated sports club with rules encouraging safe and legal use of firearms and a range certified for the shooting activity and intends to use the MSSA in an event at that sports club, or
- 3. wishes to use the MSSA in a capacity equivalent to that described in section 29(2)(e) of the Arms Act 1983 ('theatrical purposes'), or
- 4. requires the MSSA for occupational purposes.
